# Network Quality Assurance Program

## SELECTION

The selection criteria considered in the development of Medicare Select Plan hospital networks include market preference, range of services provided, relative costs and utilization management activities. Hospitals must be licensed by the Department of Health and Environmental Control and are responsible for ensuring that all health care professionals (physicians, technicians, nurses, etc.) meet all applicable state laws and regulations. Hospitals must also be Medicare certified.

The hospitals are credentialed by the BlueCross BlueShield of South Carolina credentialing department. We base retention of hospitals in the Medicare Select Plan network on the hospital's ability to provide all updated licensing information as required during the initial selection process. Licenses must be in good standing, and hospitals must notify BlueCross BlueShield of South Carolina of any action against licenses, certifications or accreditations.

## TERMINATION

Medicare Select Plan network hospital agreements may be terminated by either party with or without cause by giving written notice at least 90 days prior to the expiration of any one-year term. We will immediately terminate from the Medicare Select Plan network any hospital which does not maintain the licenses, certifications or accreditations as required by law.

## OVERSIGHT

The Quality Assurance Program of the Medicare Select Plan hospitals is the responsibility of the medical director of BlueCross BlueShield of South Carolina. The activities of the program are the responsibilities of the manager of quality programs. The medical director and the manager of quality programs administer the program under the direction of the Quality Medical Advisory Panel (QMAP). The QMAP is composed of officers of the company and was formed to oversee all quality activities.
